The Registry may, upon request by a competent Swiss authority, ask You provide a Swiss correspondence address within 30 days. The registry will delete the domain name if the You do not comply with the request in a timely manner.

#### Section .LI.4. Registration term

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and done before the Expiration date.

#### Section .LI.5. Personal data

In application with Our accreditation contract with .LI Registry, We must retain commercial correspondence, supporting documentation, titles and log files classified according to domain names for a period of 10 years from the end of registration of a

domain name.

You consent to the collect, use, copying, distribution, publication, in particular in the Registry public Whois database if applicable, modification and other processing of Your personal data by the Registry, its technical provider and their designees and agents for the purposes of providing domain name registration services and in accordance with the Registry privacy policy.

- Your domain name was transferred at least 60 days prior to the request.

The transfer does not change the domain name Expiration date.

## Section .LI.9. Ownership change

The ownership change process is available on Our Interface, it requires the confirmation of the two parties by e-mail.

The owner change does not change the domain name Expiration date.

# Section .LI.10. Deletion process

Upon the Expiration, We suspend (Hold) the domain name for 9 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain name goes into Redemption Period for an additional 40 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
