

ANNEX .PT - SPECIAL CONDITIONS FOR THE .PT ccTLD



In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .PT domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

Section .PT.1. Trustee authority and Registry

.PT is the official country code Top-Level-Domain (ccTLD) of Portugal. The following diagram presents the various parties involved and the Trustee Authority for the .PT ccTLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .PT.2. Registration terms and conditions

When You apply to register a .PT domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .PT domain names, as defined by FCCN, and which may be viewed at the following page:

This contract are binding between You and the .PT Registry. The special conditions contained herein do not replace these Rules, but rather form part of them. You acknowledge to have fully understood and accepted these Rules on Our Website.

Section .PT.3. Special requirements

.PT special requirements are available at:

.PT domain names are open to anyone.

To register a .PT domain name, You must agree to the following conditions:

- the registration term is 1 year,
- to avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 2 days before the Expiration date**,
- provide and maintain accurate, reliable and up-to-date personal contact information, failing this the .PT Registry can delete Your domain name,
- some words are reserved: <https://www.dns.pt/en/regras-de-dominios> (Article 9), as well as domain names containing two characters followed by two hyphens,
- geographical names directly registered under .PT (not provided by Gandi) are reserved to the legal administrative authority (<https://www.dns.pt/en/regras-de-dominios> Article 11b), this rule does not apply to .COM.PT domain names,
- in case of speculative or abusive registration (in particular violation of the rights of third parties), the Registry may suspend the domain name for a period of 30 days, during which the holder of previous right can request its registration. Upon the expiration of this period, the Registry may delete the domain name or reactivate it in the name of the initial registrant depending the case (<https://www.dns.pt/en/regras-de-dominios> Article 35).

During the registration process, please indicate:

- for legal persons Your VAT number or equivalent,
- for Portuguese natural persons Your fiscal number, for other natural persons Your ID number,
- Your acceptance or refusal to accept the .PT domain name Alternative Dispute Resolution Policy (acceptance by default).

Section .PT.5. Storage of contact information

You accept that .PT Registry can access Your personal data and display it in a public [Whois](#) database.

You can request in writing to the Registry to not disclose some personal information from this public database.

Section .PT.6. Dispute resolution policy

The .PT Registry has set forth a specific voluntary .PT domain name Alternative Dispute Resolution Policy that You agree to fully abide by (except in cases of express refusal during the registration of Your domain name):

Section .PT.7. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that:

- You have the domain's authorization code (this code can only be used once and **is valid for just 30 days**) and the process number of the domain. You can retrieve these codes on the Registry's [interface](#),
- Your domain name does not expire soon (We recommend to start the transfer request at least one month before Expiration).

The transfer's completion requires your confirmation (by e-mail).

The transfer of a .PT domain name does not change the domain's Expiration date.

According to the technical rules of the Registry, it is not possible to set a Transfer prohibited status on a .PT domain name, to avoid any transfer request.

Section .PT.8. Ownership change

Owner changes are not available on Our Website. If You need to change the ownership of a domain name, please contact Our customer service department (documents will be required).

The owner change of a .PT domain name does not change the domain's Expiration date.

Section .PT.9. Deletion process

One day before the Expiration date, the domain name is released by Gandi to the Registry. All associated technical services are deactivated.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
