

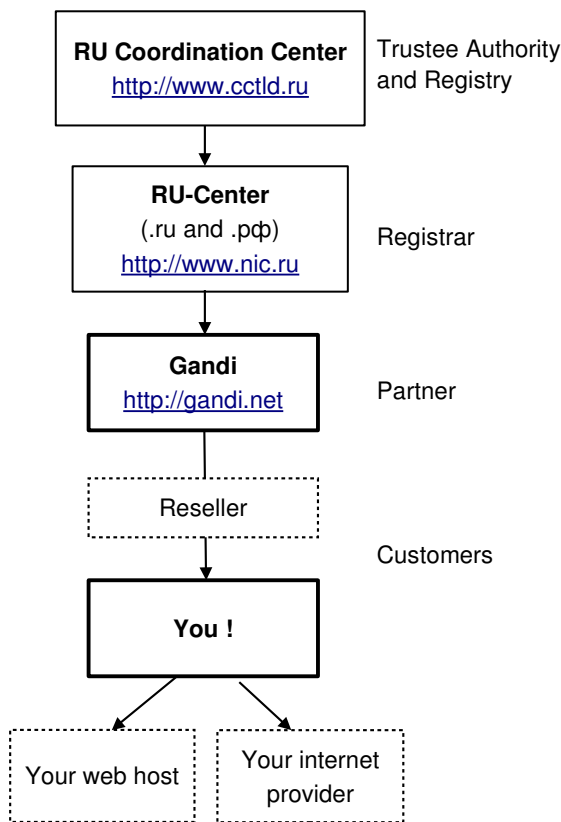

In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .RU or a .PΦ domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

Section .RU/.PΦ.1. Trustee authority and Registry

.RU is the official country code Top-Level-Domain (ccTLD) of Federation of Russia and .PΦ (.XN--P1AI) is the official IDN ccTLD of Federation of Russia. The following diagram presents the various parties involved and the Trustee Authority for the .RU and .PΦ ccTLDs:

Section .RU/.PΦ.2. Registration terms and conditions

When You apply to register a .RU or a .PΦ domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .RU and .PΦ domain names, as defined by RU Coordination Center and RU-Center, and which may be viewed at the following pages:

These contracts bind You to RU Coordination Center and RU-Center. The present special conditions are not substitutes to these Rules, but are a part of it. You acknowledge to have fully understood and accepted these Rules on Our Website.

Section .RU/.PΦ.3. Special requirements

.RU and .PΦ domain names are open to **non-Russian** organizations and individuals.

Domain names in **.PΦ are only available in Cyrillic characters**. However, IDN (Internationalized Domain Names) are not available for .RU domain names.

To register a .RU or a .PΦ domain name, You must agree to adhere to the following conditions:

- the registration term is 1 year,
- to avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 3 days before the Expiration date**,
- the owner must be an organization (legal person) or individual **living outside Russia** (the full name is required, abbreviations of names and cyrillic characters are not allowed), and the first name and last name of the official representative is required (for legal persons),
- it is not allowed to change an existing handle. If You want to change any contact data, You will have to create a new handle,
- please make sure that a **valid and working email address** is associated to the contact handles, as this is **checked by RU-Center**. If the email address is not working, You will get an error,
- some words are reserved ([List of Reserved second-level Domain Names](#)) or prohibited (in particular terms included into the "Stoplist"),

- the nameservers (DNS) must be correctly configured for the associated domain name, such that they pass the zone check of RU-Center: <http://nic.ru/dns/docs/en/nserver.html>.

Registration procedure

To registered a .RU or a .PΦ domain name, please indicate:

- for individuals: Your passport number, its issue date and the issuing authority (including country) and Your birthdate,
- for legal persons: Your incorporation number, the address associated to Your Gandi account must correspond to Your legal address.

Verification procedure

At any time, RU-Center may contact You (via Gandi or directly) for a verification request of Your personal data and require clarification and/or additional documents.

During the time of the verification procedure, RU-CENTER may suspend Your requests relative to the management of Your domain name and in particular any request of transfer, change the owner, or perform an early deletion.

Failing to answer within a deadline of 7 days, or if the personal data that You have registered are inaccurate, RU-CENTER may refuse any operation on Your domain names (in particular renewals), suspend, or delete Your domain names, and refuse any new registration.

Section .RU/.PΦ.5. Storage of contact information

You accept that the Registry and RU-Center can access Your personal contact information and display it in the public [Whois](#) database.

However, personal information of individuals (natural persons) is not disclosed in the Registry [Whois](#) public database.

RU-Center has set up a form to contact the owner of a domain name, available from [Whois](#) of the domain name on the RU-Center website.

All personal and technical information as well as all data about modification associated with Your domain name is recorded during the entire duration of the registration of the domain name, plus the 25 following years.

Section .RU/.PΦ.5. Dispute resolution policy

The Registry does not have any particular dispute resolution

procedure in place concerning .RU and .PΦ domain names. However, in the event of a complaint, You must comply with these rules: http://www.cctld.ru/en/domens_ru/registration.php

Section .RU/.PΦ.6. Transfer (change of Registrar)

Transfers of .RU or .PΦ domain names are **not available on Our website**, please contact Our customer service department. The procedure is performed directly with RU-Center (a [form](#) with Your ID proof must be sent to RU-Center).

Before any request, please be sure that:

- Your domain name does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration),
- the last transfer and the last owner change have been done since more than 30 days (in case of transfer between RU-Center and a RU-Center Partner or between RU-Center Partners, in principle these deadlines do not apply).

The transfer of a .RU or a .PΦ domain name does not change the domain's Expiration date.

Section .RU/.PΦ.7. Ownership change

Owner changes are **not available on Our website**, please contact Our customer service department. The procedure is performed directly with RU-Center (a [form](#) with Your ID proof must be sent to RU-Center).

Before any request, please be sure that:

- Your domain name does not expire soon (We recommend that you start the owner change request at least one month prior to its Expiration),
- the last transfer and the last owner change were done sooner than 30 days prior.

The owner change of a .RU or a .PΦ domain name does not change the domain's Expiration date.

Section .RU/.PΦ.8. Deletion process

2 days before the Expiration date, the domain name is released by Gandi to the Registry. All the associated technical services are deactivated.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
