### Section .Al.8. Transfer (change of Registrar)

The process is started on Our interface. Before requesting the transfer of the domain name, please be sure that:

- You have the domain name authorization code (supplied by Your current Registrar),
- · Your domain name does not have a TransferProhibited status,
- Your domain name does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration).

Upon successfully transferring a domain name, the registration period is extended by two years.

## Section .AI.8. Ownership change

The ownership change process is available on Our interface, it requires the confirmation of the two parties by e-mail.

The owner change of a .AI domain name does not change the Expiration date of the domain name.

# Section .Al.9. Deletion process

One day after Expiration, the domain name is suspended for 30 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain name goes into Redemption Period for an additional 59 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or by as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, it will go to auction at <a href="http://auction.whois.ai">http://auction.whois.ai</a> (on the next 3<sup>rd</sup> Friday of the month at noon Anguilla time). These auctions will go for about 10 days but late bidding can extend it some. If the domain name has not been registered during the auction process, then it will become available for registration under the "first-come first-served" basis.
