#### ANNEX .HT - SPECIAL CONDITIONS FOR THE .HT TLD

version 1.5 - October the 31st 2023

In addition to Gandi's <u>Domain name registration contract</u>, the registration and use of a .HT domain name implies the acceptance of and compliance to the present special conditions contained herein.

All legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>Domain name registration contract</u>. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

# Section .HT.1. Naming organization

.HT is the official country code Top-Level-Domain (ccTLD) of Haiti.

### Section .HT.2. Registration policies

When You apply to register a .HT domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .HT domain names, as defined by the Registry which may be viewed at the following pages: <a href="https://nic.ht/en/nom-de-domaine/charte-de-nommage">https://nic.ht/en/nom-de-domaine/charte-de-nommage</a>

#### Section .HT.3. Special requirements

.HT domain names are open to anyone.

To register for a .HT domain name, You must adhere to the following conditions:

- the registration term is from 1 to 5 years,
- to avoid any deletion of the domain name, the renewal must be paid and funds cleared no later than 2 days before the Expiration date,
- You must provide and maintain accurate, reliable and up-to-date personal contact information, failing the .HT Registry and CoCCA can delete Your domain name,
- You do not acquire property rights of the domain name registered but rather that You are granted exclusive user rights of the domain name.
- some words are reserved or prohibited:
- https://nic.ht/en/nom-de-domaine/charte-de-nommage (Article 19)
- names containing two characters followed by two hyphens are not allowed.

Once You have made the registration request on Our website, You (or the administrative contact) will receive 2 emails from the Registry. The first, to inform You of Your rights and obligations, the second, containing a link in order to activate Your domain name by accepting the Registrant Agreement and the Acceptable Use Policy of the Registry, and by confirming the validity of Your contact details. This activation procedure must be completed on the registration of Your domain name, the anniversary of registration, the renewal, or when performing an owner change. Failing to complete this procedure within the deadline given will result in Your domain name being suspended and then deleted by the Registry.

# Section .HT.4. Registration term

The registration term is from 1 to 5 years for requests made during the general opening. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared before the Expiration date.

### Section .HT.6. Personal data

You consent to the collect, use, copying, distribution, publication, in particular in the Registry public <u>Whois</u> database if applicable, modification and other processing of Your personal data by the Registry, its technical provider and their designees and agents for the purposes of providing Registry services as defined in the Registry and in accordance with the Registry privacy policy.

## Section .HT.7. Dispute resolution policy

# Section .HT.8. Transfer (change of Registrar)

The transfer-in process may be initiated on Our Interface. Before requesting the transfer of the domain name, please make sure You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- · does not have a TransferProhibited status,
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration),
- was created at least 60 days prior to the request,
- has not been transferred within the last 60 days.

Upon successfully transferring a domain name, the registration period is extended by 1 year.

### Section .HT.9. Ownership change

The ownership change process is available on Our Interface and requires the confirmation of both parties by e-mail.

The owner change of a domain name does not change the Expiration date.

# Section .HT.10. Deletion process

Upon the Expiration of the domain name, We suspend (Hold) the domain name for 45 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain name goes into Redemption Period for an additional 30 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, the Registry shall place the domain name in "Pending Delete" status for several days, and then delete the domain name,

which will become available for registration on a "first-come first-served" basis.

### Section .HT.11. Registrant obligations

You agree to provide and maintain accurate, reliable and up-to-date personal contact information. Failing to do so, the Registry may suspend and/or delete Your domain name.

You acknowledge and agree that distributing malware, abusively operating botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to applicable law are expressly prohibited. Failing to comply with this provision, You expose Yourself to the suspension of Your domain name, in addition to the prosecution for the prejudice caused to third parties and to the penalties mentioned under applicable law.

You commit Yourself to indemnify, defend and hold harmless the Registry and its subcontractors, and their directors, officers, employees, agents and affiliates from and against any and all claims, damages, liabilities, costs, and expenses, including reasonable legal fees and expenses, arising out of or relating to, for any reason whatsoever, the registration of Your domain name. This indemnification obligation shall survive the termination or expiration of the present contract, whatever may be the cause.

## Section .HT.12. Rights of the Registry

You acknowledge and accept that the Registry reserves the right to deny, cancel or transfer any registration or transaction, or place any domain name on registry lock, hold (suspension), or similar status as it deems necessary, in its unlimited and sole discretion:

- to enforce the rules and policies established by the Registry each as amended from time to time,
- that is not accompanied by complete, accurate, and up-to-date information, or where required information is not updated or corrected, as required by the rules and policies established by the Registry,
- for violation of the present contract or the rules established by the Registry,
- · to protect the integrity and stability of the domain names system,
- to comply with applicable laws, regulations, policies, government rules or requirements, request of law enforcement or in accordance with an order or decision by a competent court or administrative authority, or any dispute resolution service provider the Registry may retain to oversee the arbitration and mediation of disputes,
- to establish, assert, or defend the legal rights of the Registry or a third party, or to avoid any actual or potential civil or criminal liability on the part of or damage to the Registry, its affiliates, subsidiaries, contracted parties, officers, directors, representatives, employees, contractors, and stockholders,
- to correct mistakes made by the Registry or any Registrar in connection to the registration of a domain name,
- as otherwise provided in the terms and conditions and the contracts of the Registry.

The Registry also reserves the right to place Your domain name in « lock » status, « hold » status or similar status during resolution of a dispute.
