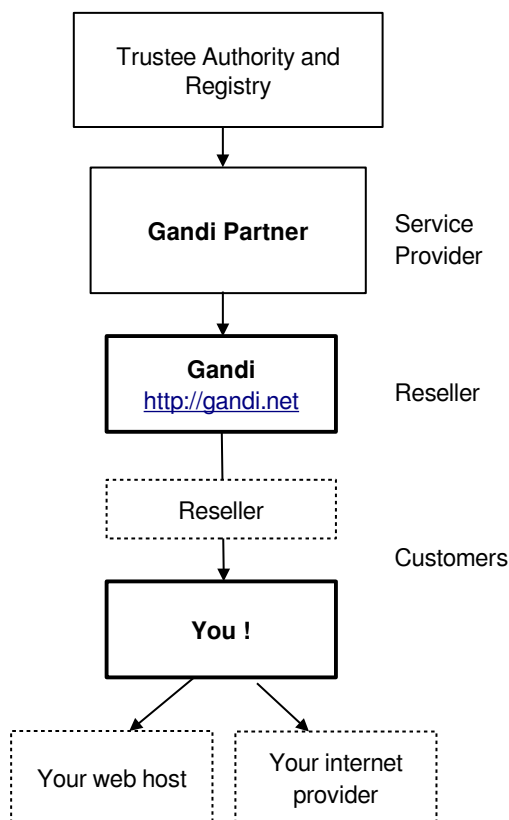
In addition to Gandi Corporate Special Conditions and Gandi's General Terms and Conditions for domain name registration, the registration and use of a domain name in the extensions mentioned above imply the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts are presented to You at the time of the subscription to Our Services. Capitalized terms have the definition attributed to them in Our General Terms and Conditions of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

### Description of the service

In the framework of its Gandi Corporate service, Gandi allows You to register Your domain name in the additional extensions mentioned above only available to Our Gandi Corporate customers, via one of Our partners. The following diagram presents the various parties involved in the providing of this service.



When You apply to register a domain name in one of the proposed extensions, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of the extension chosen, as defined by the Trustee Authority and/or the Registry concerned. These contracts are binding between You and the Trustee Authority and/or the Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules.

In accordance with Our Contracts, You agree to provide and maintain accurate, reliable and up-to-date personal contact information, failing this, the Registry concerned can delete Your domain name or refuse its registration. You also accept that the Registry and Our partner can access Your personal contact information and display it in the public Whois database.

To avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 2 days before the Expiration date** (at the earliest 60 days before the expiration date). **Upon the Expiration of the domain**, We suspend (Hold) the domain name for 89 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period. If the domain is neither renewed within these deadlines, the Registry will delete the domain name, which will become available for registration on a “first come first served” basis.
