

## Special conditions for additional extensions under the Gandi Corporate service specific to the extensions .HR, .SI, .SK

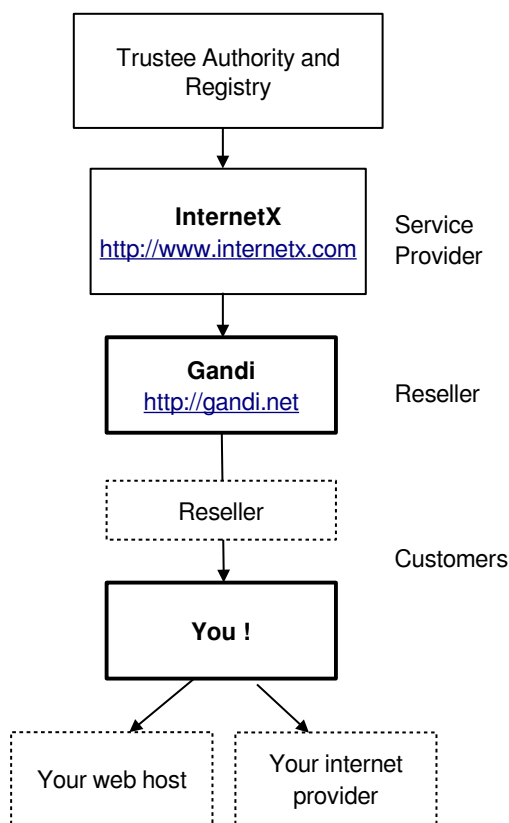
In addition to Gandi Corporate Special Conditions and Gandi's General Terms and Conditions for domain name registration, the registration and use of a domain name in the extensions mentioned above imply the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts are presented to You at the time of the subscription to Our Services. Capitalized terms have the definition attributed to them in Our General Terms and Conditions of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

### Description of the service

In the framework of its Gandi Corporate service, Gandi allows You to register Your domain name in the additional extensions mentioned above only available to Our Gandi Corporate customers, via the service provider, InternetX. The following diagram presents the various parties involved in the providing of this service:



When You apply to register a domain name in one of the proposed extensions, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of the extension chosen, as defined by the Trustee Authority and/or the Registry concerned. These contracts are binding between You and the Trustee Authority and/or the Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules.

Furthermore You agree to accept the InternetX rules and conditions available at the following addresses:

In accordance with Our Contracts, You agree to provide and maintain accurate, reliable and up-to-date personal contact information, failing this, the Registry concerned can delete Your domain name or refuse its registration. You also accept that the Registry and InternetX can access Your personal contact information and display it in the public Whois database.

Please note that under some proposed extensions, the modification of the DNS associated to Your domain name is charged by the Registry concerned and/or InternetX, consequently You agree to paid to Gandi the costs related to these changes (please contact Our Corporate team for further information in particular about prices).

The registration of a domain name in the proposed extensions is usually done manually by the Registry concerned. The validation and processing time of Your application by the Registry can therefore vary from several hours to several weeks depending on the extension chosen. In addition, the registration of a domain name under some proposed extensions requires the submission of a form and/or documents allowing to the Registry to verify Your eligibility to the registration of a domain name under the extension chosen. In this case, the registration of Your domain name will be effective only after receipt and validation of these documents by the Registry. If during the registration period of Your domain name, You are no longer eligible for registration of a domain name in the chosen extension according to the applicable rules, the Registry will be authorised to delete Your domain name.

### Special conditions for the .HR and .COM.HR extensions

The Registry for .HR, the official extension of Croatia, is [CARNet](#). The rules applicable to .HR domain names are available at the following address:

.HR domain names are open to individuals residing in Croatia and to legal persons registered in Croatia. A local presence in Croatia is also required for the administrative contact. The maximum number of domain names that can be registered by the same person is limited (maximum 9 domain names for legal persons and 1 domain name for individuals).

.COM.HR are open to anyone and the maximum number of .COM.HR domain names that can be registered by the same person is not limited.

During the registration process, please indicate the fiscal number (OIB for local contacts or VAT) of all contacts associated to the domain name.

According to the Registry rules, owner change are not possible in principle. You also must not allow to third parties to use Your domain name, except for subdomains that You may have created. The Registry may delete Your domain name if it notices/establishes that Your domain name is exclusively or mainly used by a third party.

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 32 days before the expiration date. 31 days before the Expiration date**, the domain name is released by Gandi to the Registry, **the domain can not be renewed or restored**, it will be deleted by the Registry, and will become available for registration under the "first-come first-served" basis.

### Special conditions for the .SI extension

The Registry for .SI, the official extension of Slovenia, is [ARNES](#) (Academic and Research Network of Slovenia). The rules applicable to .SI domain names are available at the following addresses:

.SI domain names are open to anyone. You must specify nameservers (DNS) that are correctly configured for the domain name that You intend to register.

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 32 days before the expiration date. 31 days before the Expiration date**, the domain name is released by Gandi to the Registry, **the domain can not be renewed or restored**, it will be deleted by the Registry, and will become available for registration under the "first-come first-served" basis.

### Special conditions for the .SK extension

The Registry for .SK, the official extension of Slovakia, is [SK-NIC](#). The rules applicable to .SK domain names are available at the following address:

.SK domain names are open to Slovak citizens residing in Slovakia, individual entrepreneurs established in Slovakia and legal persons established in Slovakia. A local presence is also required for the administrative contact. If You do not have a local presence, InternetX can provide it (please contact Our Corporate team).

During the registration process, please indicate Your ICO (ID number). Once Your request has been made on Our website, a form will have to be filled out and sent to Gandi with the required documents within the deadline given.

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 32 days before the expiration date. 31 days before the Expiration date**, the domain name is released by Gandi to the Registry, **the domain can not be renewed or restored**, it will be deleted by the Registry, and will become available for registration under the "first-come first-served" basis.
