

ANNEX .ARCHI - SPECIAL CONDITIONS FOR THE .ARCHI TLD

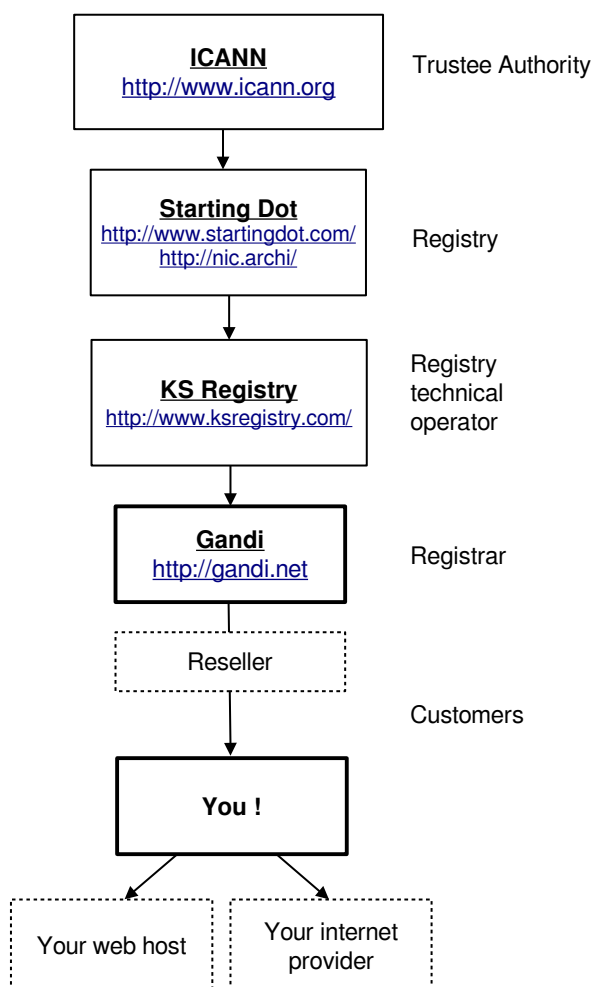

In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .ARCHI domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

Section .ARCHI.1. Trustee authority and Registry

.ARCHI is a generic Top-Level-Domain (gTLD) exclusively developed for the community of architects. The following diagram presents the various parties involved for the .ARCHI TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .ARCHI.2. Registration terms and conditions

When You apply to register a .ARCHI domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .ARCHI domain names, as defined by ICANN and Starting Dot and which may be viewed at the following pages:

These contracts bind You to the .ARCHI Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and to have accepted these rules on Our Website.

Section .ARCHI.3. Launch rules

The .ARCHI domain name launch will occur in three (3) phases: Sunrise, Landrush and general opening.

The Sunrise phase will run from April 10th, 2014 to June 10th, 2014. The Landrush phase will run from May 9th, 2014 to June 10th, 2014. General opening is scheduled for June 23rd, 2014. These dates are not definitive and are subject to change by the Registry.

Preregistrations during both the Sunrise, Landrush and general opening phases are available at Gandi: domain names can be ordered at that time, but will not yet be registered or reserved.

By registering a .ARCHI domain name, You agree to be bound by the terms and conditions of the initial launch of the .ARCHI, including without limitation the Sunrise phase and the Landrush phase, and the Sunrise Dispute Resolution Policy.

You also acknowledge that Starting Dot has no liability of any kind for any loss or liability resulting from the proceedings and processes relating to the Sunrise phase or the Landrush phase, including, without limitation: (a) Your ability or inability to register a registered name during these periods, and (b) the results of any dispute over a Sunrise registration.

Section .ARCHI.4. Special requirements

.ARCHI domain names are restricted to individual professional architects or architecture firms registered as members of a Union Internationale des Architectes ("UIA") Member Section (i.e., ; either a Member Section or an Allied Member Section of UIA as defined in UIA Bylaw Section II.3. The current list of UIA Member Sections and Allied Member Section is available in section "What is UIA?" on UIA website at www.uia-architectes.org).

If You do not meet these eligibility requirements, You may register a .ARCHI domain name under the condition that:

- You do not use Your .ARCHI domain name so as to confuse the public about Your qualification and/or status as a professional architect;
- You do not claim the title of architect or of architectural engineer and Your .ARCHI domain name will point to online content in relation with professional architectural engineering services;
- You commit to not undermine, denigrate or detract the profession of architectural engineering and/or the status of architects;
- Your .ARCHI domain name registration shall not include comparative, defamatory or untrue statements;
- Your .ARCHI registration shall not violate national and international architectural laws or regulations;
- You may not use Your .ARCHI domain name for the promotion, involvement in or assisting in any illegal activity, nor for the promotion of business opportunities that are not permitted and directly or indirectly related to architecture; and
- You may not use Your .ARCHI domain name to offer the sale of goods and/or tools and/or services related to architectural services and/or engineering without an appropriate license.

You acknowledge and accept the Registry may, without prior notice, check Your eligibility and Your use of a .ARCHI domain name.

Section .ARCHI.5. “Trademark Claim Notice” period

In accordance with ICANN rules, during the Landrush period and 90 days upon the general opening, a “Trademark Claim Notice” period will run.

During this period if the domain name for which You requested registration is identical to a trademark that is registered and validated with TMCH (according to the “labels” generated), You will receive a warning notice (“Trademark Claim Notice”) in real time on Our interface informing You that a third party has rights to the domain name You requested.

You must confirm or cancel Your registration request, with full knowledge of the notice and its consequences. It being specified that if You do not confirm the notice, Your request will not be sent to the Registry.

If You confirm Your registration request, third parties who own an identical mark are notified of Your registration.

For requests made in preregistration, beginning one day prior to the opening of the period concerned, Gandi will notify You by email of the “Trademark Claim Notice” and Your registration request will be put in “error” until You confirm or cancel Your registration via Our interface. It being specified that, in accordance with ICANN rules, if You do not confirm the notice, Gandi will not send Your registration request to the Registry upon the opening of the period concerned and can not, in any case, be held liable of the non-registration of Your domain name and particularly if the domain name is registered by a third party who has validated the “Trademark Claim Notice” upon the opening of the period concerned.

It is Your sole and entire responsibility to confirm, if You want, all the notices received before the opening of the period concerned and the sending of Your request to the Registry.

Section .ARCHI.6. Reserved names and premium domain names

Some words are reserved or prohibited:

 (specification 5. schedule of reserved names), names containing two characters followed by two hyphens and names beginning or

ending by a hyphen are not allowed.

The registration of "premium" domain names is not available on Our interface, You would need to contact Our customer service department for this.

For requests made in preregistration, if the domain name You have preregistered is a “premium” domain name, Your request will be put in “error” and You will be notified by email. Then You will be able to either pay the additional costs applicable to “premium” domain names in order to validate Your registration request or cancel Your request. It being specified that if You do not contact Our customer service department and do not pay the additional costs applicable to “premium” domain names, Your registration request will be not sent to the Registry.

Section .ARCHI.7. Registration term

The registration term is 2 years minimum for requests made during the Sunrise period, 2 years minimum for requests made during the Landrush period and from 1 to 10 years for requests made during the general opening.

Defensive registrations during Sunrise phase are made for a ten (10) years term.

To avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**.

“Premium” domain names are subject to specific prices that will be communicated by Our customer service department upon request.

Section .ARCHI.9. Storage of contact information

In application of ICANN contracts, all personal and technical information associated with the registration of Your domain name is recorded and made available to ICANN and IRON MOUNTAIN (ICANN's designated Registrar Data Escrow agent), in addition to messages pertaining to each registration or modification, during the entire duration of the registration of the domain name, plus the two following years.

You therefore consent to the use, copying, distribution, publication, including in the public [Whois](#) database, modification and other processing of Your personal data by the Registry and its designees and agents, consistent with the purposes defined by the Registry.

Section .ARCHI.10. Dispute resolution policy

The Registry has adopted the ICANN dispute resolution procedures UDRP (Uniform Dispute Resolution Policy) and URS (Uniform Rapid Suspension System) for .ARCHI domains, that You agree fully abide by.

Section .ARCHI.11. Transfer (change of Registrar)

The transfer-in process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration),
- was created at least 60 days prior to the request,
- has not been transferred within the last 60 days.

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

Section .ARCHI.12. Ownership change

The ownership change process is available on Our Interface, and it requires the confirmation of the two parties by e-mail.

The owner change of a domain name does not change the domain's expiration date.

Section .ARCHI.13. Deletion process

Upon the Expiration of the domain, We suspend (Hold) the domain name for 45 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain goes into Redemption Period for an additional 30 days, and all associated technical services are deactivated. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration on a "first-come first-served" basis.

Section .ARCHI.14. Registrant representations and guarantees

You agree to provide and maintain accurate, reliable and up-to-date personal contact information. Failing to do so, the Registry may delete Your domain name.

In any case, You acknowledge and agree that distributing malware, abusively operating botnets, phishing, piracy, trademark or

copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to applicable law are expressly prohibited. Failing to comply with this provision, You expose Yourself to the suspension of Your domain name, in addition to the prosecution for the prejudice caused to third parties and to the penalties mentioned under applicable law.

You commit Yourself to indemnify, defend and hold harmless Starting Dot and its subcontractors, as well as each of their respective directors, officers, employees, affiliates and agents from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and expenses arising out of or relating to Your domain name registration. This indemnification obligation shall survive the termination of the present contract, whatever may be the cause of this termination.

Section .ARCHI.15. Exclusion of liability and actions of the Registry

You expressly acknowledge and accept that the Registry shall be entitled, that it deems necessary, in its sole and entire discretion to reject, delete, suspend, transfer to a third party or place in "lock" status, "hold" status or similar status Your domain name:

- to enforce the rules and policies established by Starting Dot and ICANN each as amended from time to time,
- to protect the integrity and stability of the domain names system,
- to comply with applicable laws, regulations, policies, government rules or requirements, request of law enforcement or in accordance with an order or decision by a competent court or administrative authority, or any dispute resolution service provider the Registry and ICANN may retain to oversee the arbitration and mediation of disputes,
- to avoid any liability, civil or criminal, on the part of Starting Dot, as well as its affiliates, subsidiaries, officers, directors, and employees,
- to correct mistakes made by Starting Dot or any Registrar in connection with the registration of a domain name.

The Registry also reserves the right to place Your domain name in « lock » status, « hold » status or similar status during resolution of a dispute.

In addition, in the context of registration during the Sunrise period, You expressly acknowledge and accept that the Registry shall be entitled, but not obligated, to reject Your request or to delete, suspend, or transfer to a third party Your domain name if the Registry receives notice that Your "SMD" file is under dispute.

You acknowledge that the Registry has no liability of any kind for any loss or liability resulting from the proceedings and processes relating to the Sunrise or Landrush period, including, without limitation:

- the ability or inability of a person to obtain a domain name during these periods,
- the results of any dispute over a Sunrise registration.
