

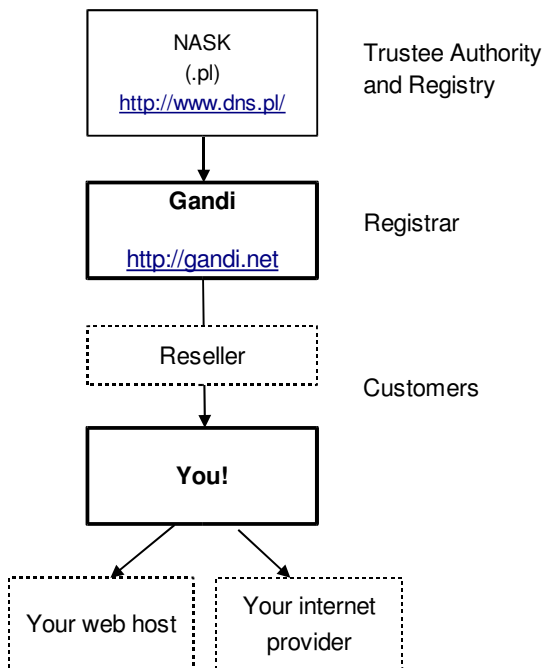

In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .PL domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

### Section .PL.1. Trustee Authority and Registry

.PL is the official ccTLD of Poland. The following diagram presents the various parties involved and the Trustee Authority for the .PL ccTLD. You can view the information and special rules of each party involved by clicking on the respective links.



### Section .PL.2. Registration terms and conditions

When You apply to register a .PL domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .PL domain names, as defined by the Registry NASK, which may be viewed at the following addresses:

### Section .PL.3. Special requirements

.PL special conditions are available at: <http://www.gandi.net/domain/pl/info>

Second level .PL domain names are open to anyone worldwide.

As exception to Our General Terms and Conditions of Domain Name Registration:

- .PL maximum registration term is 3 years,
- the name servers (DNS) that You indicate must be correctly configured for the domain that You wish to register (<http://www.dns.pl/english/d-change.html#5> ; [http://www.dns.pl/english/technical\\_cond.html](http://www.dns.pl/english/technical_cond.html))
- data of private persons are protected by the Registry.

Gandi does **not** provide: the Waiting List Service option; domain names corresponding to the name of a voivodship, county, commune or town in .pl ioctI (can only be submitted directly to the NASK); third-level domain names (functional and regional) requiring special conditions; reserved domain names (ldap, mailto, news, sip, tel, www, ftp, http, https).

### Section .PL.5. Dispute resolution policy

According to the [Regulations](#), domain name disputes are resolved by the Arbitration Court or any other competent Court.

If a third party initiates against You a legal action in the Arbitration Court, claiming that You have infringed its rights, **You must submit to that Arbitration Court, within 3 months and before the domain's Expiration date, a duly signed arbitration clause, otherwise the domain name will be deleted by the Registry NASK, without penalty or refund.**

Modifications upon a disputed domain will be suspended until the dispute is concluded, but **not later than for one year** from the date NASK is notified, except if the Complainant demonstrates that the dispute has not yet been concluded.

### Section .PL.6. Transfer

The transfer (change of Registrar) procedure can be viewed at: <http://www.dns.pl/english/registrar/transfer.html>

The transfer request begins on Our [transfer interface](#). When We receive the authorization from the Registry to transfer this domain, You will receive an e-mail from the Registry, containing an URL

(web address) that You must use to approve the transfer.

For transfers from NASK, You will additionally have to use a special form ([http://www.dns.pl/cgi-bin/en\\_transfer.pl](http://www.dns.pl/cgi-bin/en_transfer.pl)), and to fax documents to the Registry.

Before requesting a transfer, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire in less than 24 days (We recommend that You

start the transfer request at least two months before the domain's expiration),

- was created or renewed more than 21 days ago.

**The transfer to Gandi does not include any renewal.**

Trade (changing the owner during a Registrar transfer) is not available.

#### **Section .PL.7. Deletion process**

Domain names that are not renewed before the Expiration date will be deleted.
